## SUBMISSION GUIDELINES FOR AUTHORS

**POLIFONIA - ACADEMIA PAULISTA DE DIREITO International Law Review** publishes two issues every year. The Issues aim to receive high standard submissions, according to its Editorial Line in "Law, Economics, Humanities, Social and Political Science, Philosophy and Ethics".

**POLIFONIA** reviews and accepts articles year-round on a rolling basis. The Editorial Board carefully considers every article regardless of when it is submitted, so **POLIFONIA** encourages all authors to submit their works whenever they believe they are suitable for publication.

The submissions can be sent in Portuguese, English, French, German, Italian and Spanish.

All submissions must adhere to the following guidelines:

- 1. The submitted manuscript should not be published previously or under consideration for publication.
- 2. Title, Abstract and Keywords in the official idiom and in a second language, accepted by the Review.
- 3. The submission must contain an abstract of no more than 250 words, and 5 keywords, maximum.
- 4. Footnoting must be mandatorily done according to the 19<sup>th</sup> Edition Harvard Bluebook Citation.
- 5. The font must be Times New Roman with size 12, for headings and for the remaining body with footnotes in Times New Roman, size 10.

6. Line spacing -1.5 and 1.0 (footnotes) and a margin of 3 cm on the left and 2cm on all other

sides.

7. Co-Authorship is permitted.

8. Plagiarism will be viewed with zero tolerance.

a workshop or conference or circulated online. We never disclose the names of our peer reviewers or


